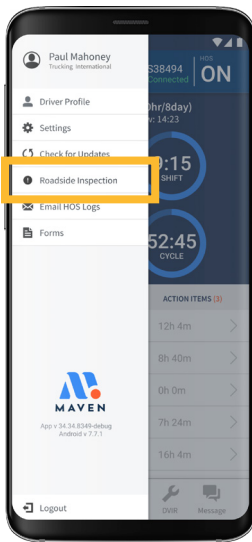


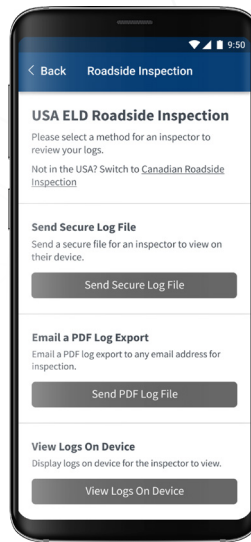
DOT INSTRUCTION SHEET

1 Access Roadside Inspection Mode



1. Open the application menu and press **Roadside Inspection**.



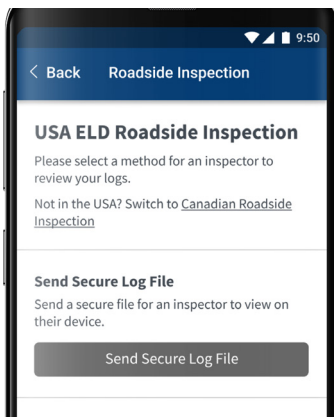
2. Select how to transfer logs:

Send Secure Log File
Securely sends a log file to FMCSA eRODs system. Does not produce an email.

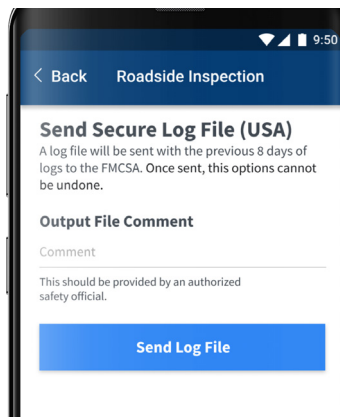
Email a PDF Log Export
Produces an email with a PDF log export file. Can be sent to any email address.

View Logs On Device
Displays logs on your device for the review.

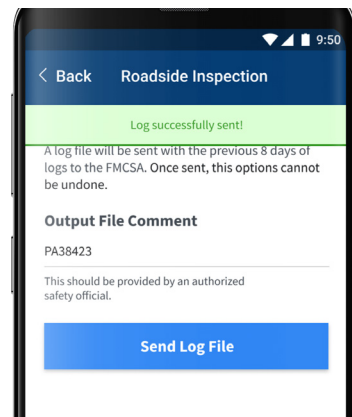
2 Send Secure ELD Log File



1. From the Roadside Inspection menu, press **Send Secure Log File**.



2. Enter the officer-provided output file comment. Press **Send Log File**.



3. A confirmation will display when the logs have been successfully transferred.

- View previous and next day's logs.
- View information about the driver, their log, and their carrier.
- View information about the vehicle and required data from the engine.
- View driver's HOS grid and their duty status changes for the day.

ELD Malfunction Reporting and Record Keeping Requirements

DRIVERS, in the event of an ELD Malfunction, are required to:

1. Provide written notice to the carrier within 24 hours.
2. Have available accurate electronic or paper logs for the current 24-hour period and the previous 7 days.
3. Continue forward with manually prepared RODS for no more than 8 days.

CARRIERS in the event of an ELD Malfunction, are required to:

1. Repair or replace the malfunctioning ELD within 8 days of discovering the condition.
2. Require the driver to maintain paper RODS until the ELD is back in service.
